Whereas, the Uttarakhand Electricity Regulatory Commission (Commission) had issued a Tariff Order dated 23.10.2009 for the FY 2009-10 on Uttarakhand Power Corporation Limited's (UPCL) ARR Petition approving the retail tariffs to be charged by UPCL from various categories of consumers, which were effective from 01.10.2009.

Whereas, an Appeal bearing No. 41/10 & IA Nos. 51/10 & 52/10 of 2010 has been filed by an HT industrial consumer - M/s. Polyplex Corporation Ltd. (Appellant) before the Hon'ble Appellate Tribunal for Electricity, New Delhi (Hon'ble Tribunal) for setting aside Commission's abovesaid Tariff Order dated 23.10.2009, the Hon'ble Tribunal vide its order dated 04.05.2010 was pleased to direct the Commission as follows:

"As this appeal is against the tariff order, we feel it will be appropriate to inform the consumers at large through an advertisement in the Newspapers so that they may send their objections, if any, to the Tribunal giving reference of the Appeal and serving the same on the Appellant. The Commission will publish public notice informing that an Appeal has been filed before the Appellate Tribunal against Retail Tariff orders dated 23.10.2009 and eliciting objections from consumers within two weeks from the date of publication of the notice in daily newspapers; one in Hindi and one in English at the cost of the Appellant. The objectors need not be impleaded."

As the above appeal is against the Tariff Order dated 23.10.2009, which specifies tariffs for all categories of electricity consumers in the State of Uttarakhand, the electricity consumer at large are hereby informed that in case, any consumer is interested to oppose the Appeal of M/s. Polyplex Corporation Ltd. before the Hon'ble Tribunal, he may send his objections, if any to Hon'ble Appellate Tribunal at the following address and also serving the same on the Appellant:
