Terms and conditions for supply are as follows:

1. The bidder should enclose the copy of an authorization certificate from OEM i.e. Apple.
2. They should be registered for VAT/CST/SST and Income Tax and should enclose copies of relevant certificates.
3. Prices quoted in the bid should be inclusive of all taxes and FOR at UERC's office.
4. If the goods are not delivered within the stipulated time period a penalty of Rs.50/- per day for each item shall be charged & deducted from their bill. Order shall be cancelled if the delay is of more than 20 days.
5. The payment shall be made through cheque within 07 after delivery and installation of goods at UERC Office, Dehradun and acceptance of the goods on the basis of certification by the UERC's personnel.
6. In case of any dispute, decision of Secretary, UERC shall be final.
