Inviting Comments on the Petition filed by 'PTCUL under Regulation 37(1) of the UERC (Conduct of Business) Regulations, 2014, Clause No. 3.2 and 14A of the Transmission Licensee read with section 18 of Electricity Act and other relevant provisions of the Electricity Act, 2003 for amending the terms and conditions of the Transmission License of Power Transmission Corporation of Uttarakhand Ltd.

Power Transmission Corporation of Uttarakhand Limited (PTCUL), a Transmission Licensee in the State of Uttarakhand has filed a Petition before the Hon'ble Uttarakhand Electricity Regulatory Commission under Regulation 37(1) of the UERC (Conduct of Business) Regulations, 2014, Clause no. 3.2 and 14A of the Transmission Licensee read with section 18 of Electricity Act and other relevant provisions of the Electricity Act, 2003 for amending the terms and conditions of the Transmission License of PTCUL so as to increase the limit of Minor Investment from Rs. 2.5 Crores to Rs. 10 Crores.
