Order

This order relates to the Petition for Annual Performance Review for FY 2015-16 and Multi Year Tariff for the Control Period FY 2016-17 to FY 2018-19 filed by State Load Despatch Centre (SLDC), hereinafter referred to as the Petitioner, on 30.11.2015.

2. The Petition filed by SLDC had certain infirmities/deficiencies which were conveyed to SLDC vide Commission's letter dated 09.12.2015 asking it to rectify the said infirmities so that the Petition could be admitted. SLDC vide its letter dated 16.12.2015 has removed the critical deficiencies.
3. Based on the submissions made by SLDC, the Commission directs to admit the Petition provisionally for further processing subject to the condition that SLDC shall furnish any further information/clarifications as deemed necessary by the Commission during the processing of the Petition and provide such information and clarifications to the satisfaction of the Commission within the time frame as may be stipulated by the Commission failing

which the Commission may proceed to dispose off the matter as it deems fit based on the information available with it.

4. The Commission further directs the Petitioner to publish a public notice within 3 days from the date of this Order detailing the salient features and facts of the ARR petitions & proposals filed by it in the format given at **Annexure-1** in at least two daily newspapers (one Hindi and one English) widely circulated in the area of its operation both in Hindi and English languages for comments by all stakeholders and public at large. The Petitioner is also directed to place the Petition on its website and its headquarters/other offices for inspection or making relevant extracts available to the public.
