

**UTTARAKHAND POWER CORPORATION LIMITED
PUBLIC NOTICE**

Inviting Comments on UPCL's proposal for determination of Additional Surcharge in accordance with the provisions of UERC (Terms and Conditions of intra-State Open Access) Regulations, 2015 to meet the fixed cost of UPCL arising out of its obligation to supply electricity to the Open Access Consumers for the period October 2022 to March 2023

1. Uttarakhand Power Corporation Limited (UPCL), the sole Distribution and Retail Supply Licensee in the State, has filed a Petition before Uttarakhand Electricity Regulatory Commission (UERC or Commission) for determination of Additional Surcharge in accordance with the provisions of UERC (Terms and Conditions of intra-State Open Access) Regulations, 2015 to meet the fixed cost of UPCL arising out of its obligation to supply electricity to the Open Access Consumers.
2. The computation of Additional Surcharge to be levied on Open Access Consumers, for the period 01.10.2022 to 31.03.2023 is given in the Tables below:

- (i) The details of stranded energy due to open access and open access drawn by the open access consumers at State Periphery for the period from October 2021 to March 2022 are as follows:
